Project Description:

The Ohio Department of Transportation is proposing a project to resurface SR 295 from SLM 21.54 to 23.93 in Lucas County. There will be no deep excavation. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2023 and last approximately 150 days. During construction, one lane of traffic will be maintained at all times.

This project has been written and approved based off of Stage 2 Plans.
