Project Description:

The Lucas County Engineer is currently proposing to resurface Bancroft Rd from St James Wood to McCord and McCord Rd from Bancroft to Regents Park due to poor pavement conditions. All work is within the existing right of way, and there will be no impact to utilities. This project does not include impacts to any waterways or floodplain, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2023 and last approximately 90 days. During construction, one lane of traffic will be maintained at all times.

This document was written and approved based off of Stage 2 plans.
