Project Description:

The Ohio Department of Transportation is currently proposing to resurface SR-2 from Port Clinton East Corp Line to Bay bridge and rehab 2 bridges due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met. There will be no impacts to any ecological or historically significant resources, and there will be no work below the OHWM. Construction is expected to begin in the fall of 2023 and last approximately 420 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
