Project Description:

The Village of Swanton is proposing to reconstruct Hallett Ave from Airport Hwy to Garfield Ave due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways therefore no US Army Corps of Engineers permits are required. The required floodplain coordination will be completed prior to construction. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the Spring of 2024 and last approximately 90 days. During constructions, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
