Project Description:

The Lucas County Engineer is proposing to resurface a section Laskey Rd with spot full depth repairs due to poor pavement conditions and 370' of new sidewalk. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2023 and last approximately 30 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
