Project Description:

The Wood County Engineer is currently proposing to replace the superstructure of the bridge that carries East Broadway Road over Cedar Creek between Avenue Road (State Route 795) and Ayers Road due to poor bridge conditions. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources, and there will be no work below OHWM. Construction is expected to begin in the summer of 2023 and last approximately 75 days. During construction, one lane of traffic will be maintained at all times with the exception of a 75 day detour required for the bridge work. All impacted property owners, public safety agencies, and schools have been notified of the closure.

This document was approved based on Stage 1 Plans.
