Project Description:

The City of Toledo is currently proposing to complete streetscape associated with the major reconstruction of SR-25. Approximately 380 trees will be planted in the median. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the fall of 2023 and last approximately 90 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 1 Plans.
