Project Description:

The City of Oregon is currently proposing to resurface three segments of Coy Rd, including expanded shoulders throughout and new sidewalks in some areas due to poor pavement conditions. Additional work includes signage, pavement markings, ADA curb ramps and related work, as necessary. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 3 plans.
