Project Description:

The Wood County Engineer is currently proposing to mill and resurface Tracy Rd from north of Commodore Drive to the Northwood Corporation limits due to poor pavement conditions. Additional work includes spot full depth repairs and associated pavement markings. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 30 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
