Project Description:

ODOT is proposing to repair a failing embankment within the I-475/I-75 interchange in Perrysburg, Wood County. There will be no new right of way or utility impacts. No impacts to any listed species or their habitat are expected. There will also be no impacts to any jurisdictional waterways so no permit from the USACE is required. This project is not within a floodplain and will have minimal impacts to any historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 45 days. Traffic will be maintained during construction.

This document was written and approved based on Stage 2 plans and all documentation can be found in the project file.
