Project Description:

The City of Wauseon is currently proposing a project that consists of milling and resurfacing approximately 0.40 miles of Oak Street in Fulton County due to poor pavement conditions. Crosswalks and curb ramps will be upgraded to meet ADA regulations. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological resources. It has been determined that the proposed project is a type of undertaking that has 'minimal potential to cause effects' to historic properties and is not a part of a larger undertaking. Construction is expected to begin in the summer of 2024 and last approximately 30 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
