Project Description:

The City of Toledo is currently proposing to mill and resurface the existing asphalt pavement due to poor pavement conditions. Additional work includes, spot full depth repairs, new striped bike lanes, and a signal upgrade at Whitmer Dr. Project scope includes sidewalk, minor drainage, curb and curb ramp improvements/repairs as needed to complete resurfacing. All work is within the existing and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the spring of 2024 and last approximately 60 days. During construction, on lane of traffic will be maintained at all times.

This document was approved based on Stage 1 plans.
