Project Description:

The City of Rossford is currently proposing to resurface Glenwood Rd from Mandell Road to north of Buck Road in Wood County due to poor pavement conditions. Additional work includes necessary pavement repairs, stone berm improvements, and pavement markings. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 1 Plans.
