Project Description:

The Seneca County Engineer is currently proposing to replace a bridge in Seneca County on Cr-62 over Green Creek, west of the Village of Green Springs due to poor bridge conditions. The project will replace existing steel beam bridge with prestressed concrete box beams with pipe pile stub abutments and include associated guardrail replacement and approach roadway work. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. A floodplain permit will be obtained prior to construction. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 60 days. During construction, a detour will be posted for the road closure.

This document was written and approved based on Stage 3 plans.
