Project Description:

The City of Napoleon is proposing to reconstruct Oakwood Ave from Perry Street to Independence Drive due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways therefore no US Army Corps of Engineers permits are required. The required floodplain coordination has been completed and is located in the project file. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the Spring of 2024 and last approximately 160 days. During constructions, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
