Project Description:

The Ohio Department of Transportation is currently proposing to construct a roundabout at the intersection of SR 269 and Danbury Rd in Ottawa County for safety reason. All work is within the existing right of ways and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the fall of 2024 and last approximately 240 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
