Project Description:

The Williams County Engineers Office is currently proposing to resurface CR 304 (CR 12C) from US 6 to Townline Rd and CR 309 (CR D) from SR 576 to Townline Rd due to poor pavement conditions. Additional work includes guardrail replacement, associated bridge waterproofing, and other minor necessary scope items. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to start in the spring of 2024 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
