Project Description:

The Wood County Engineer is planning to replace the bridge on Reigle Rd (TR-27) over Yellow Creek in Wood County, southeast of the Village of Deshler due to poor bridge conditions. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 60 days. This bridge is currently closed to all traffic, so no maintenance of traffic or public involvement is required.

This document was approved based on Stage 2 Plans.
