Project Description:

The Ohio Department of Transportation/Lucas County Engineers Office is currently proposing to resurface Sylvania Metamora Rd from SR-295 to Washburn Rd in Lucas County due to poor conditions. Additional work includes spot full depth repairs, pavement markings, and other necessary related work. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways; therefore, no US Army Corps of Engineers permits are required. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 60 days. This document was approved based on Stage 2 plans.
