Project Description:

The Lucas County Engineer is currently proposing a project in Lucas County to resurface two intersections: Holland Sylvania Rd at Sylvania Ave and Holland Sylvania Rd at Central Ave. The scope includes milling the existing pavement, performing spot partial depth repairs, placing a two-course asphalt concrete overlay, adjusting manholes, tying down the shoulders, bringing drives to grade, placing pavement markings and other related work due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 60 days. During construction, at least one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
