Project Description:

The City of Toledo is currently proposing to mill and resurface Laskey Rd from Douglas Rd to Jackman Rd due to poor pavement conditions. Additional work includes, spot full depth repairs and minor associated drainage improvements. All work is within the existing right of way and there will be no impact to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the spring of 2024 and last approximately 60 days. During construction, one lane traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
