Project Description:

The Ohio Department of Transportation is currently proposing to resurface US-6 in Sandusky County due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. It as determined by the district 2 hydraulic engineer that there would be no impacts to the floodplain. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the spring of 2024 and last approximately 90 days. During construction, one lane of traffic will be maintained at all times.
