Project Description:

The Ohio Department of Transportation is currently proposing to resurface SR-12 from SLM 3.47 to 13.085 in Seneca County and US-23 from SLM 9.98 to 11.88 within city limits of Fostoria due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program Requirements will be met and no permit is required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the spring of 2025 and last approximately 120 days. During construction, one lane traffic will be maintained at all times.

This document was written and approved based on Stage 2 plans.
