Project Description:

The Toledo-Lucas Port Authority is currently proposing a project in Lucas County to mill and resurface W Airport Service Rd from S. Berkley Southern Rd to Terminal Rd, and S Berkley Southern Rd from Airport Highway (SR-2) to W. Airport Service Rd due to poor pavement conditions. Additional work includes pavement markings, signage upgrades, and other minor necessary scope items. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the spring of 2024 and last approximately 60 days. During construction, one lane traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
