Project Description:

The Ohio Department of Transportation is currently proposing to stabilize the bank on I-280 at SLM 5.00 due to a slide. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 240 days. During construction, one lane of traffic will be maintained at all times.
