Project Description:

The Ohio Department of Transportation is currently proposing to resurface portions of SR 235 in Wood County due to poor pavement conditions. Additional work includes pavement repairs on portions of SR 18 in Wood County and to perform any necessary related work. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. It was determined by the district 2 hydraulic engineer that there would be no impacts to the floodplain. There will be no impacts to any ecological or historically significant resources. Construction is estimated to begin in the spring of 2024 and last approximately 75 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
