Project Description:

The city of Waterville is currently proposing to mill and resurface Waterville-Swanton Rd (SR-64) from approximately 850' east of Pray Blvd to approximately 800' west of Waterville-Monclova Rd. due to poor pavement conditions. Additional work includes spot full depth repairs, pavement markings, and other minor necessary scope items. All work is within existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 30 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
