Project Description:

The Ohio Department of Transportation is currently proposing to resurface Sr-163 in Ottawa County due to poor pavement conditions. Additional work includes the full depth replacement of the shoulders East of Marblehead. This project is located within a special flood hazard area. It was determined by the district 2 hydraulic engineer that there would be no impacts to the floodplain. All work near historic resources was coordinated with the Ohio History Preservation Office and it was determined that there would be no adverse effect on any historic properties. Construction is expected to begin in the fall of 2025 and last approximately 90 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
