Project Description:

The City of Maumee is currently proposing to mill and resurface South Detroit Ave from River Rd to the Anthony Wayne Trail (US 24) due to poor pavement conditions. Additional work includes a road diet to narrow the roadway and reduce the number of lanes to two instead of three lanes and add a bike lane, including curb ramp upgrades, pavement markings, signage improvements, and streetscape elements. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 60 days. During construction, one lane traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
