Project Description:

The City of Bellevue is currently proposing to do a full depth reconstruction of US 20 due to poor pavement conditions. Additional work includes storm sewer repairs, curb replacements, upgrading deficient curb ramps, and addition of a left-turn lane with associated signal update. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. All work near historic resources was coordinated with the Ohio Historic Preservation Office and it was determined that there would be no adverse effect on an historic properties. Construction is expected to begin in the spring of 2025 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 1 plans.
