### Project Description:

The City of Bowling Green is currently proposing to mill and resurface West Gypsy Lane Rd to South Main St and East Gypsy Lane Rd from I-75 to Dunbridge Rd due to poor pavement conditions. Additional work includes spot full depth repairs, pavement markings, and other minor necessary scope forms. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains; therefore, no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 60 days. During construction, one lane traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
