Project Description:

The Ohio Department of Transportation is currently proposing to resurface SR 582 in Wood County from SR 25 to Mercer Rd and from SR 199 to Pemberville Rd due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project is located in a special flood hazard area however the project will not impact the floodplain. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 75 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
