Project Description:

The Ohio Department of Transportation is currently proposing to resurface US 20A from SLM 0.00 to 2.98, US 127 from SLM 2.38 to 4.74 and SR 109 from SLM 8.11 to 14.84 due to poor pavement conditions. Additional work includes performing any necessary related work. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administration is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the spring of 2025 and last approximately 180 days. During construction, one lane of traffic will be maintained at all times.
