Project Description:

The Ohio Department of Transportation is currently proposing to resurface US-6 in Williams County from SLM 0.00 to 3.03, SR-49 in Williams County from SLM 0.00 to 2.62 and SR-191 in Williams County from SLM 0.00 to 2.45 due to poor pavement conditions. Additional work includes enhanced crossings and pedestrian safety improvements on SR-49 within the Village of Edgerton. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. It was determined by the district 2 hydraulic engineer that there would be no impacts to the floodplain. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2026 and last approximately 120 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
