Project Description:

The Ohio Department of Transportation is currently proposing to resurface SR-4 in Seneca County from SLM 7.52 to 13.23 and SR-18 in Seneca County from SLM 15.39 to 17.92 due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. It was determined by the district 2 hydraulic engineer that there would be no impacts to the floodplain. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2025 and last approximately 150 days. During construction, one lane of traffic will be maintained at all times.

This project was approved based on Stage 2 Plans.
