Project Description:

The Ohio Department of Transportation is currently proposing to resurface SR-19 in Seneca County from SLM 6.07 to 9.18, SEN-228 in Seneca County from SLM 0.00 to 1.30 and SR-590 in Seneca County from SLM 0.00 to 0.48 due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2025 and last approximately 365 days. During construction, one lane of traffic will be maintained at all times with the exception of a 3 day detour required for the bridge work. All impacted property owners, public safety agencies, and schools have been notified of the closure.
