### Project Description:

The Wood County Engineer is currently proposing to resurface the entire length of Five Point Road within Perrysburg Township in Wood County due to poor pavement conditions. Additional work includes spot full depth repairs, widening approximately 2 miles of roadway from 18-19' to 20', pavement markings, stone berms, and other minor necessary related items. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met in coordination with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2025. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
