Project Description:

The City of Bowling Green is currently proposing to install a Pedestrian Hybrid Beacon at the intersection of Wooster Street (SR-64) and Maple Street for safety reasons. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological resources. All work near historic resources was coordinated with the Ohio Historic Preservation Office and it was determined that there would be no adverse effect on any historic properties/no historic properties effected. Construction is expected to begin in the summer of 2024 and last approximately 90 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
