Project Description:

The Village of Portage is currently proposing to resurface SR-25 in the Village of Portage due to poor pavement conditions. Additional work includes spot repairs, new curb and gutter with associated drainage improvements, and new sidewalks. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2026 and last approximately 180 days. During construction, one lane of traffic will be maintained at all times.
