District 12 construction inspection contract during SFYs 2025-2026 for construction bridge paint inspections.

Categorical Exclusion (CE) "Certified" C List

The following project types do not require detailed documentation for NEPA compliance. C(1) Activities that do not involve or lead directly to construction, such as planning and research activities; grants for training; engineering to define the elements of a proposed action or alternatives so that social, economic, and environmental effects can be assessed; and Federal-aid system revisions that establish classes of highways on the Federal-aid highway system.

ODOT hereby confirms that the above project types are identified in 23 CFR 771.117(c) and as listed, certify that the following criteria have been met:

1. The action does not have any significant environmental impacts as described in 23 CFR 771.117(a).
2. The action does not involve unusual circumstances as described in 23 CFR 771.117(b).
3. The action does not involve the following:
 1. The acquisition of any temporary or permanent right-of-way.
 2. The use of properties protected by Section 4(f) of the Department of Transportation Act (49 U.S.C. 303).
 3. Require coordination with the State Historic Preservation Officer per ODOT's Section 106 PA.
 4. Any U.S. Coast Guard construction permits or any US Army Corps of Engineers Section 404 permits, 408 actions or Flowage Easement impacts.
 5. Any work in streams or wetlands.
 6. Any work encroaching on a regulatory floodway or any work affecting the base floodplain (100-year flood) elevations of a water course or lake.
 7. Construction in, across or adjacent to a river designated as a component or proposed for inclusion in the National System of Wild and Scenic Rivers.
 8. Any changes in access control.
 9. The use of a temporary road, detour or ramp closure unless the use of such facilities satisfies the following conditions:
 1. Provisions are made for access by local traffic and so posted.
 2. Through-traffic dependent business will not be adversely affected.
 3. The detour or ramp closure, to the extent possible, will not interfere with any special local event or festival.
 4. The temporary road, detour or ramp closure does not substantially change the environmental consequences of the action.
 5. There is no substantial controversy associated with the temporary road, detour, or ramp closure.
 6. Any known hazardous materials sites, not including solid waste, or previous land uses with potential for hazardous materials remain within the right-of-way.
 7. The action will not impact suitable habitat for a federally listed endangered or threatened species within the occupied range or critical habitat for the species.

If one or more of the above conditions are not satisfied, a C1, C2, or D level CE must be prepared in accordance with ODOT's NEPA Assignment Categorical Exclusion Guidance. Appropriate environmental documentation must be completed in EnviroNet.
