Project Description:

The Village of North Baltimore is currently proposing an improvement project of Broadway Street from Main Street to Rudolph Road in North Baltimore, Wood County due to poor pavement conditions and to improve safety. The work will include pavement milling and resurfacing, full depth pavement reconstruction, curb replacements, curb ramp upgrades, and replacement of drainage structures. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecologically or historically significant resources. Construction is expected to begin in the summer of 2025 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.
