Project Description:

The City of Tiffin is currently proposing to resurface US-224 from intersection of SR-18 (W Market St) to approximately 600 feet east of St. Lawrence Drive in Seneca County due to poor pavement conditions. Additional work includes spot full depth repairs and pavement markings. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the fall of 2025 and last approximately 45 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 1 Plans.
