Project Description:

This is a safety-funded project along SR-51 to add sidewalk and install an enhanced crossing with PHB and refuge median island. Includes minor drainage changes, ADA curb ramps, curbs, and raised curb median. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the spring of 2026 and last approximately 30 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 1 Plans.
