PM resurfacing from the Medina County Line to Pearl Rd (US-42) in Strongsville and Middleburg Hts.

All work within existing r/w.

A Cultural Resources Records Check was performed by district environmental staff Megan Romanchok, Environmental Specialist 2, using the online OSHPO ArcMap Resource Map. No Cultural Resources listed on or determined eligible for listing on the National Register of Historic Places were identified within and/or immediately adjacent to the proposed project area.
