The Ohio Department of Transportation will be performing electrical maintenance for 3 bridges and 4 storm water pump stations. There will be no impact to waterways or state/federally listed species. This project will begin Winter 2025 and the maintenance contract will last 1 year. All traffic will be maintained on the bridges when the work is being performed.
