Project Description:

The Village of Edgerton is proposing new sidewalks, crosswalks, curb ramps, and pavement markings to address deficiencies in pedestrian safety and connectivity throughout the village. Temporary right of way will be needed from 24 residential parcels and 6 commercial parcels. Permanent right of way will be needed from 10 residential and 2 vacant properties.

Since there is no work within any waters of the US and there are no floodplain impacts, no permits are required. There are some ecological species located within 1 mile of the project sites, but there will be no impacts to any state or federally listed species or their habitat. This project has a minimal potential to cause impacts to any historical resources. Construction is expected to begin in the summer of 2027 and last approximately 60 days. During construction, a minimum of one lane of traffic in each direction will be maintained.

Air Remarks

Hence this project will not result in any meaningful changes in traffic volume, vehicle mix, location of the existing facility, or any factor that would cause an increase in emissions impacts relative to the no-build alternative. The project is exempt under 40 CFR 93.126. No air quality analysis is required.
