Project Description:

The Lucas County Engineer is currently proposing a project in Sylvania Township in Lucas County to construct sidewalks on various roads and path extensions to improve access to Central Trail Elem, Hill View Elem and Arbor Hill JH, Stranahan Elem, and Whiteford Elem along with the installation of marked crosswalks with high visibility signage to increase safety. All work is within the existing right of way. This project is located within a special flood hazard area. All National Flood Insurance Program requirements will be met and coordination with local floodplain administrators is on-going. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2026 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.
