### Project Description:

The City of Clyde is currently proposing a project to resurface and improve pedestrian facilities on Maple Street and Race Street. Work would include signal removals, new signage, enhanced crosswalks with RRFB's, curb ramps, striping, and other necessary related scope items. All work is within the existing right of way, and there will be no impact to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2025 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 plans.
