**Project Description:**

Resurface Wilson Mills Road (CR-8) section G-L from Heath Rd to Thwing Rd in Munson Township in Geauga County.

All work within existing r/w.

A Cultural Resources Records Check was performed by district environmental staff Corey Czinger, Environmental Specialist 3, using the online OSHPO ArcMap Resource Map. No Cultural Resources listed on or determined eligible for listing on the National Register of Historic Places were identified within the proposed project area. The undertaking is a type which has minimal potential to cause effects to historic properties in accordance with Minimal Potential to Cause Effect - Appendix A of the Section 106 Programmatic Agreement. No further coordination is required. The Records Check can be found in the Project File Under Cultural Resources/Project Information. District approval date 12/16/24.

The project location is not located in a floodplain. This C1-level resurfacing project has such a remote chance of affecting base food elevation that it is excluded from analysis.
