Project Description:

The City of Rossford is proposing a project to replace existing rectangular rapid flashing beacons with pedestrian hybrid beacons at two locations: 1) Superior St at Rossford Recreation Center and 2) Superior St at Elm St to increase safety. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2026 and last approximately 60 days once the poles have been received. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
